

The Margaretta Township Trustees met in regular session on May 5, 2016 at 7 p.m.

Present were Mr. Bias and Mr. Pooch.

Mr. Bias moved, seconded by Mr. Pooch to approve the minutes from the April 21, 2016 meeting, as presented by Fiscal Officer Mary Ann Lindsley. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Pooch to accept the financial reports that were presented by the Fiscal Officer. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Pooch to approve and sign warrants #15127-15160 and efts that were submitted by the Fiscal Officer for the Trustees approval. Vote: all ayes.

Mrs. Jane Ann Williams was at the meeting representing the Thomas Neill Woman's Relief Corp Mrs. Williams gave a brief update on the Memorial Day Program. She also mentioned that we will not be having the Flags of Honor this year at the Cold Creek Celebration.

Mr. Jim Neill gave his Road/Cemetery Dept. report. Jim said that he checked into our Issue II Project and they said we can't change anything.

Mr. Neill mentioned that we are having a drainage issues between Bogart and Miller Rds. on Old RR. He will get quote on getting the issue repaired.

Mr. Bias moved, seconded by Mr. Pooch to approve 10 hrs. of computer training to be held here at the township through EHOve for a cost of \$950. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Pooch to accept the resignation of Austin Riley from our Fire Department effective 5/5/2016. Vote: all ayes.

The Fire Department would like to get some equipment for working out. They would like to recommend 30 minutes a day of activity. The Trustees said to get quotes on what they would like to purchase.

Mr. Bias moved, seconded by Mr. Pooch to rehire Sandi Martin as a part time seasonal worker for our records retention effective June 6, 2016 at a rate of \$10.50/hr. Vote all ayes.

Mr. Bias moved, seconded by Mr. Pooch to contract with Entech Inc. for our tire recycling day on June 11, 2106 for a cost of \$4806 for two loads. Vote: all ayes.

We received a plague from Margaretta Schools Athletic Department thanking us for the help in their scoreboard project.

Mr. Bias moved, seconded by Mr. Pooch to pass Resolution 2016-04 applying for the outdoor Metro Park grant. Roll Call Vote: Mr. Bias – yes Mr. Riesterer- absent and Mr. Pooch- yes.
