

The Margaretta Township Trustees met in regular session on October 1, 2015.

Present were Mr. Bias, Mr. Pooch and Mr. Riesterer.

Mr. Pooch moved, seconded by Mr. Riesterer to approve the minutes from the September 17, 2015 meeting, as presented by Fiscal Officer Mary Ann Lindsley. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Pooch to approve and sign warrants #14549-14589 and direct deposits that were submitted by the Fiscal Officer for payment. Vote: all ayes.

Mr. Pooch moved, seconded by Mr. Riesterer to accept the financial reports that were submitted by the Fiscal Officer. Vote: all ayes.

Sandi Dwight from 820 Maple Ave. needs to have the catch basin riser removed/cut to allow storm water to flow into the basin. Also weeds north of her property need to be mowed.

Zoning: Junk vehicles at the 6400 block of Bogart Road. Tom Johnson followed up on the complaint.

Fire Department Report: John Secue is going to be leaving to go to Sandusky Fire Department. We do not have his resignation yet. The Trustees asked Chief Johnson to advertise and test to establish a list for hiring.

The new phone system was discussed. Components are in need of programming.

The radios are to be installed in the trucks in the upcoming weeks.

Work on the parking lot is to begin next week.

The west side of the fire station building is weathering badly. After discussion it was decided to wait until spring to get bids for fixing it.

Road/Cemetery Department: Work on Heywood road has been completed.

We only received one bid for the storm water project on Bardwell Road. Paul Fox bid \$5180.00 on the project.

Jim said we need to take 100% of the salt from the summer salt program. Our balance is 150 ton at \$71.09/ton for a total cost of \$10,663.50.

Mr. Pooch moved, seconded by Mr. Riesterer to accept the resignation of Andrew Orshoski effective September 27, 2015. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Pooch to replace 100' of storm sewer on Bardwell Rd for a cost not to exceed \$5200.00. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Pooch to approve the vacation requests submitted: Rob Street 16 hours on December 30, 2015, October 17, 2015 for 24 hours, Mike Jesberger for November 14, 16 & 18, 2015, Dan Minor for November 20, 22, & 24, 2015, Dan Strayer for October 21, 2015, November 23, 25 & 27, 2015, December 6 and December 24 2015. Vote: all ayes.
