

The Margareta Township Trustees met in regular session on April 21, 2011.

Present were Mr. Pooch, Mr. Bias and Mr. Riesterer.

Mr. Bias moved, seconded by Mr. Pooch to approve the minutes from the April 7, 2011, as presented by the Fiscal Officer, Mary Ann Lindsley. Vote: all ayes.

Mr. Pooch moved, seconded by Mr. Bias to approve and sign warrants 10621-10654, that were presented for payment by the Fiscal Officer. Vote: all ayes.

Mr., Bias moved, seconded by Mr. Pooch to accept the financial reports that were presented by the Fiscal Officer. Vote: all ayes.

Chief Keimer gave his report. He mentioned that we had a lightning strike and there was some damage to the radios. Chief mentioned that we are still in the running for the grass Fire truck. We didn't receive the state grant that we applied for. Chief Keimer said to remove Josh Clark from our paid on call firefighter list. He did not complete his probation.

Mr. Dean Gasser was at the meeting with a complaint about a dilapidated building on his neighbor's property at 6015 Heywood Rd. The property owner had received a letter last spring about this and we received a response saying it would be taken care of. Since it wasn't taken care of we'll send another letter stating that something needs to be done. If nothing is done we will issue a violation. The township has several other properties that need to be addressed. A list is to be put together and we will review it at our next meeting.

Mr. Tom Johnson gave a zoning report. He said that the lady from the railroad has not called him back concerning the Cody property. Tom will send a letter to the railroad about the property. He has pictures showing the property with the railroad setbacks. Tom also wanted to know if he has any jurisdiction at the trailer parks. There are issues that need to be addressed. As far as we know trailer parks fall under state jurisdiction. There are two zoning hearings on May 2, 2011.

Mr. Riesterer had a letter to the county commissioners about the Access Management Board of Appeals. The letter mentioned that we would be ok with allowing one of the board members to be from an incorporated area of the county, but not to be able to have the whole board be from the incorporated areas of the county. This could leave the unincorporated areas without representation on the appeals board. The trustee all signed the letter.

Mr. Jim Neill gave his report. He had the agreement for our road maintenance. Jim mentioned that our yard waste drop off will be held on April 30 and May 7, 2011 from 9 am. to noon. Jim discussed summer help. He has had a few people interested and they are to fill out applications. The trustees would like his recommendation by the next meeting.

Mr. Pooch moved, seconded by Mr. Bias to amend our original contract with the county for. road maintenance to be for a total cost of \$27,500. Vote: all ayes. This was to include the striping of the road which we didn't include originally.

Mr. Riesterer and Mr. Neill went to the ditch petition hearing. Erie County Soil and water would like to contact Denny Messenberg about his ditch to see if he'll work with them on getting it cleaned.


Mr. Keith Kreager from Crystal Rock said that he has had a complaint about a battery business that has been moved into a residential garage in Crystal Rock.
