

The Margaretta Township Trustees met in regular session on April 4, 2013 at 7 p.m.

Present were Mr. Bias, Mr. Riesterer and Mr. Pooch.

Mr. Riesterer moved, seconded by Mr. Bias to approve the minutes from the March 21, 2013 meeting, as presented by Fiscal Officer, Mary Ann Lindsley. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to approve and sign warrants #12387-12411 that were presented by the Fiscal Officer for payment. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to accept the financial reports that the Fiscal Officer presented. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to accept the amended contract presented by Verizon. Vote: all ayes.

Mr. Keith Kreager of Crystal Rock was at the meeting. He mentioned that the Crystal Rock Landowners Assoc will hold a meeting on April 28, 2013 at 2 p.m. at the park in Crystal Rock.

Mr. Tom Johnson gave a zoning report. There were two bids submitted for the demolition of 205 Crystal Rock Rd: Terry Nichols Excavating \$6300 and Shortridge Construction \$6350.

Mr. Riesterer moved, seconded by Mr. Bias to award the contract to Terry Nichols Excavating for the demolition of 205 Crystal Rock Rd., Sandusky, Ohio. Vote: all ayes. Mr. Nichols needs to provide updated paperwork to the Fiscal Officer.

Mr. Kent Miller of our zoning board was at the meeting to present the boards proposed zoning fee changes. There was a brief discussion on the fees our zoning inspector proposed that the trustees accept and pass the new zoning fees.

Mr. Bias moved, seconded by Mr. Riesterer to pass Resolution 2013-05 passing the new zoning fees as proposed by the zoning inspector. Roll Call Vote: Mr. Bias- yes, Mr. Riesterer- yes and Mr. Pooch- yes. The new fees will go into effect on May 1, 2013.

Chief Mohr gave his Fire Report. Chief said he would like to attend the Fire Dept Instructor Conference in Indianapolis on April 25 or 26, 2013.

Mr. Bias moved, seconded by Mr. Riesterer to approve the training request of Mike Jesberger for the BG Advanced Rope Training on May 6-10, 2013 for a cost of \$525. Vote: all ayes.

Mr. Jim Neill gave a Road/Cemetery report. Mr. Neill had the agreement with the county for road work. After discussing it, this agreement was tabled so Jim can check to see if the figures were correct.

Mr. Riesterer moved, seconded by Mr. Bias to participation in the Salt Participation Program for salt for the 2013-2014 season, and to purchase 250 t. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to rehire Tom Rodriguez back as a part time seasonal summer help employee effective 4/8/2013. Vote: all ayes.


