### Chris Schaeffer, Zoning Inspector:

Mr. Schaeffer discussed the Smarsh properties in Whites Landing and the impending clean-up process.

Mr. Schaeffer also discussed the Caldwell property on Skadden Road and the possible use of funds from Erie County Land Bank to assist with clean-up.

Mr. Pooch reminded all that the ECTA summer BBQ picnic will be held on Thursday June 9<sup>th</sup> in Vermilion. Mr. Bias presented the 2022 contract for concessions at Lion's Park. The contract will be with Food Dugout Concessions at a one-time fee of \$600 plus an additional \$105 for each tournament added. Mr. Bias moved, seconded by Mr. Riesterer, to approve the contract with Food Dugout Concessions. Vote: all ayes. Mr. Bias recommended an increase in compensation for XXL LLC for the maintenance of Lion's Park. The increase will be \$13.00/hours for field work and \$130.00 for each mowing.
