# Kelly Ried, Road Department/Cemetery Department Administrative Support:

Mrs. Ried presented the updated Rules & Regulations for the Margaretta Township cemeteries. She will keep the Board apprised of any issues regarding 'green burials'. The Board will require an 'insure-a-seal' bag for all green burials. The Regs will be updated to reflect this. Mr. Pooch moved, seconded by Mr. Cullen to approve the Margaretta Township Rules & Regulations as presented with amendments for 'green burials'. Vote: all ayes.
